Action Item: Present Assembly members unanimously approved minutes from January 11th and January 25th meetings.

3) Faculty Handbook Representative Nominations & Elections

Action Item: Present Assembly members unanimously approved Xusheng Chen, College of Science & Engineering, as the Academic Assembly nominated representative for Faculty Handbook Representative.

4) Ombudsperson

- a) Ted Fortier joined the Assembly to help in the discussion of the position of the Ombudsperson and how this position came to be. He was the Academic Assembly President at the time of the original conversations.
- b) Discussion was had, topics and questions include:
 - i) Last final discussion of Ombudsperson listed in October 30, 2006 Academic Assembly minutes.
 - ii) Seattle University wanted something/-one to anonymously reflect on issues, and to find resolution in conflicts.
 - iii) How would an Ombudsperson work well at SU? What does this office have to offer for SU that EthicsPoint and/or the grievance committee doesn't?

- (1) the need for an anonymous sounding board, could provide advice, act as a mediator in conflict, would not replace existing structure
- iv) Consider the cost of this office, full-time versus half-time
- v) What is the demand for this service?
- vi) What about the steps currently in place? How can we use the current structure?
- vii) How/Why is this associate with Academic Affairs if it would be more than just a faculty service, extending to staff and/or students?
 - (1) Has this been discussed with the staff? or students?
- viii) This position/office would work within the current policies and procedures that are in place at SU.
- ix) Developing structures and resources at the start of a faculty member's career so that they can be successful.

Action Item: At the next Assembly meeting, this will be on the agenda to further discuss and determine, 1) leave the approval from 2006 as it stands, 2) reopen, discuss and revise the Assembly's proposal for this position, or 3) reject the proposal.
