III. New Curriculum Proposal: Career Courses

A. Assembly discussed topics such as: a philosophical concern (what role to these courses have at the university? something that's not traditionally academic, resources, credits?), does this information/training need to be for credit, how many students would take advantage of these courses, what are we currently doing for career assistance, could we compromise on the schedule and amount of credits?

IV. Copyright Ownership Policy, Jacquelyn Miller and Isiaah Crawford

A. SU didn't have a policy heretofore on the work that students/faculty/staff produce. This is an effort to establish a policy that won't require an individualized effort for each circumstance. Looking for feedback on this draft and possibly agreement to use as interim policy.

Action Item: Present Assembly members unanimously approved the use of this policy as interim policy, through the vetting process, minimal revisions, and review for approval by the Board of Trustees in May.
