MINUTES

- I. Minutes from 4-23-12 approved.
- II. Student Health and Wellness Survey (Guests: Kimberly Caluza, Maura O'Connor, Jay Robertson-Howell)
 - A. Survey Response Profile
 - 1. Overall response was 26.9% of participants surveyed.
 - 2. Gender: slightly higher female response rate and slightly lower male response rate than national average.
 - 3. National data includes graduate students and SU data does not. Median age for national data is 21 and median age for SU data is 20.
 - 4. Sexual orientation is fairly consistent with national data.
 - 5. Race/ethnicity: high on white response rate, underrepresented black population, higher than national Asian/Pacific Islander response rate, although consistent with SU profile.
 - B. Physical Health
 - 1.Top 10 physical health problems are consistent with national (upper respiratory complaints, allergy, back pain, asthma, UTI, STD/STI).
 - 2.SU students have higher vaccination rates than national average. We do not require the HPV vaccine, which was recently approved in males.
 - 3. Impediments to academic performance include stress, anxiety, sleep difficulties, cold/flu, work, internet activity, extracurricular activities, depression, concern for family/friend, relationship difficulties.
 - C. Violence
 - 1. Physical fight/assault reports are consistent with national averages, although verbal threats were slightly higher for SU males.
 - 2. Females report slightly higher rates of sexual touching and males report slightly higher rates of penetration sexual assault than national averages.
 - 3. In an intimate relationship, emotional abuse is the primary form of abuse for males and females.
 - D. Alcohol/Cigarette/Marijuana Usage
 - 1. Consistent with national averages (including Greek system schools), 51.9% of males and 58.6% of females used alcohol 1-9 times within the last 30 days.
 - 2. Consistent with national averages, 26.5% of students report binge drinking (five or more alcoholic drinks at a sitting) within the last two weeks.
 - 3. Perceived alcohol use is 3-5 times higher than actual use.
 - 4. Problems when drinking include doing something they regretted, unprotected sex, injury (similar to national data).
 - 5. Cigarette usage

- a. Over 66% have not used in the last 30 days.
- b.5% used all 30 days.
- 6. Marijuana prevalence
 - a.60% of students have not tried.
 - b.20% have used in the past 30 days.
- E. Sexual Health
 - 1.61% of SU students are sexually active.
 - 2. Number of sexual partners in last year averages 1.7 for females and 2.1 for males.
 - 3.43% of sexually active students do not use condoms for disease protection.
 - 4. The top three methods of pregnancy prevention are male condoms, birth control pills, and fertility awareness (ineffective).
- F. Weight and Eating Habits
 - 1. About 66% are at desired Body Mass Index and over 30% are above desired BMI.
 - 2. High portion of students trying to lose weight (body image issues).
 - 3.52.3% are not meeting exercise guidelines.
 - 4. Only 5% getting enough fruits and vegetables.
- G. Mental Health
 - 1. Felt things were helpless (46%).
 - 2. Felt very sad (69%).
 - 3. Felt so depressed difficult to function (39%).
 - 4. Stress (8% tremendous, 52% felt stressed in general).
 - 5.8% of students seriously considered suicide, 1.3% attempted.
 - 6. Females seek medication-only mental health treatment more than national average, males seeks psychotherapy-only more than national average.
- H. AcA discussion of presentation
 - 1. Surprised that verbal threats were so far above national average for males.
 - 2.25% response rate leaves large margin of difference.
 - 3. What is the plan moving forward with these findings?
 - a. Utilized by student health offices to develop educational campaigns, programming, support groups, etc.
 - b. Currently, no funding for larger campus programming.
 - c. Collaborate with other offices to handle suicide prevention.
 - d. Plan to share alcohol use perception versus actuality data to encourage moderation.
 - 4. Suggestion to share data with high schools in the community.
- III. Grant Compensation Policy (Guests: Lindsey Demeritt and Nalini Iyer)
 - A. Policy meets the federal requirements and covers both the academic year and summer months (non-academic). University Counsel has approved the document.
 - B. Grant Based Salary for Faculty is the full title. This only applies to funding that is paid from an outside source, through SU.
 - 1. We should include language clarifying this document does not cover external consultation.
 - 2. Add in friendly amendment: after the term "extramural sources" add the term "not paid through SU."
 - C. For those with a summer research grant, the policy allows for 2.7 months compensation instead of 3 months.
 - 1. Difficult for SU to prove that the faculty member has done nothing else (no prep for fall, no vacation, no advising to students). Also difficult to justify writing grant renewal while doing research at 100%.
 - 2. Most schools are moving toward 90%.

- 3. The exception is research faculty who do not have teaching assignments. The Faculty Titles Document includes a position that is a non tenure track, 100% research faculty.
- D. OMB circulars only apply to federal money but SU applies across the board. If a large amount of money is being managed by the university, it goes through an internal process where like money is like. Exceptions may be made by petition for large private grants.
- IV. Integrated Learning Environments (Guests: Sari Graven, Francesco Guerrero, Jeff Philpott)
 - A. SU committee consulted with Terry Hajduk of Hajduk, LLC on the different possibilities for developing new learning environments.
 - B. The main concept of Integrated Learning Environments is to develop spaces where formal and informal environments exist together and there is a flow of learning that takes place across the variety of environments.
 - C. Instead of long hallways with distinct classrooms, there could be a mix of social spaces, classrooms with adjustable sizes and furniture, and office spaces arranged in ways that facilitate deeper learning by tying together the entire student experience.
 - D. Whole range of ideas, from furniture to building remodel, to match different budgets.
 - E. Spaces are very malleable to different teaching styles (e.g. small closets with extra furniture to easily adjust to class styles and room set up).
 - F. Aware of issues (limitation of clinical in nursing, adjustable room barriers, issue of how to fit tech with room flexibility, etc.) but these are just general ideas to generate excitement.
 - G. Add to a fall AcA agenda to discuss faculty initiative and next steps.
- V. AcA Membership 2012-13
 - A. Nomination of Karen Cowgill to Graduate SEP.
 - 1. Vote unanimously approved.
 - B. Nomination of Mary Graham to Faculty Technology Committee.
 - 1. Vote unanimously approved.
 - C. AcA needs to appoint a College of Arts & Sciences to University Rank and Tenure Committee.
 - 1. Large number of tenure applications this year.
 - 2. Working to get all material online, but some is still in print.
 - D. Vote for AcA President and Vice President on May 21.
 - 1. Need to be current AcA members, returning next year.
 - E. AcA Members
 - 1. Chrisitan Halliburton will replace John Weaver from the School of Law.
 - 2. Karen Cowgill will replace Karen Feldt from the College of Nursing.
 - 3. The other members should be chosen by their schools/colleges by the May 21 meeting.
