- I. Review of 2-25-13 Minutes
 - A. Minutes approved with no abstentions
- II. Announcement of Public Safety Forum at 3:00pm
 - A. Based upon Law School incident last week
 - B. Also exploring the broader issue of campus security (lack of safety drills, etc.)
 - C. Vote by AcA to not end meeting early
- III. Theology and Religious Studies Program Review (Kan Liang, David Powers)
 - A. Department chair Sharon Suh not present
 - B. Department has developed a specialization in world religions
 - 1. Hired a Catholic ethicist this year
 - 2. Also requested a new faculty line for Islamic studies scholar may not be approved in this challenging budget year, but strong need for this line in the future
 - C. Decline in enrollment may be related to decline in academic rigor
 - 1. THRS enrollment has always been modest, but the department is large because of Core requirements
 - 2. Students who major in THRS take many 200 level courses, since these Core courses are the majority of the departmental courses
 - 3. Under the new Core, all 200 level courses have the same learning outcomes
 - 4. THRS majors are almost always in classes where the majority of their classmates are not part of the major
 - 5. AcA needs to know if THRS is addressing this issue
 - D. Edits
 - 1. Invite Sharon Suh to next meeting with updated memo
 - 2. Add a comment that undergraduates cannot take graduate courses due to school policy on page 3
 - 3. Ask chair and dean to address the drop in THRS enrollment in comparison to peer institutions
- **IV.** AcA President's Report from Board of Trustees
 - A. Finances
 - 1. SU is inordinately tuition dependent and our graduate enrollments are down
 - 2. About to begin largest capital campaign ever using the strategic plan to appeal to nontraditional donors and a much larger audience
 - 3. Under the new leadership of VP Connie Kanter, Finance is working to enhance its operation from top to bottom.
 - B. Athletics

- 1. Men's basketball is not producing revenue at budgeted levels.
- Women's basketball is doing well, although Connolly does not fully meet NCAA Division 1 standards
- 3. SU is continuing to fund Athletics according to the business plan developed to transition us to Division 1 status

C. HR presentation

- 1. Benefits package comparable with peer institutions
- 2. SU fringe benefits are being reduced (which will likely result in higher deductibles and lower level of annual subsidy)
- 3. Adjustment to the university's retirement benefits are also under consideration (AcA will invite Jerry Huffman to an upcoming meeting for more details)

D. Online education

- 1. Focus on two target groups: degree completion for adult learners and graduate/professional programs
- 2. Expand software and systems upgrades
- 3. Goal to have hybrid/online education in place during AY2014-15 (hybrid is usually approximately 80 online/20 in person, but flexible)

E. FY14 Budget

- 1. At the end of the FY14 budget process, every unit of the university did not experience a full 5% reduction
- 2. 4.87% tuition increase for undergraduate credits
- 3. Public safety will add 8 new positions
- 4. Budget Advisory Committee
 - a. BAC representatives from AcA need to determine how often to report back to AcA
 - b. BAC representatives also need to find out how much input they have on budget preparation in the future (may want to include in AcA Bylaws discussion)

- C. Nominee needed for Budget Advisory Committee
