Lu Jiang is a Program Manager at the Bill & Melinda Gates Foundation. Lu has 10 years of experience managing complex multi-stakeholder initiatives. In her current role, Lu focuses on providing strategic direction for the collective U.S. Program progression towards a more student-centric mindset trough investments in priority communities. Prior to joining the Bill & Melinda Gates Foundation, Lu was an award-winning civil litigator in private practice. Her areas of practice included sexual harassment, workplace discrimination, wage and hour fraud, and policy advocacy. She also clerked for the Honorable Zulema Hinojos-Fall at the U.S. Equal Employment Opportunity Commission, worked as a Legal Complaint Counselor at the American Civil Liberties Union, and served as a Clinic Attorney with the King County Housing Justice Project. A relentless champion for students and minorities, Lu founded the Equal Justice Endowment at the University of North Dakota and the Women's Empowerment Scholarship Endowment at Seattle Central Community College, both aimed at providing financial support to the most underserved student populations. Additionally, Lu is a guest lecturer at the Seattle University and Seattle Central Community College. Lu holds a B.A. in business management from the University of Washington; a J.D. from the University of North Dakota School of Law; and she is working toward a graduate certificate from the Harvard Extension School at Harvard University.



Aiko Bethea, JD, Head of Diversity & Inclusion, Fred Hutchinson Cancer Research Center

Aiko is the head of diversity and inclusion at Fred Hutchinson Cancer Research Center. In this role, she developed and implemented the first enterprise-wide diversity and inclusion strategic plan. She formerly served as a Deputy Director of Grants & Contracts Management at the Gates Foundation, where she led the team responsible for the due diligence review of investments. She also partnered to develop and implement efficient workflow processes, facilitated change management throughout the organization, and ensure dthe strategic goals of the organization were supported by solid thought partnership, tools, and process. One of the highlights for her was leading the Black Philanthropic Partnership and co-leading Gates Asians in Philanthropy - two employee resource groups at Gates.
