The **Seattle University Crime & Justice Advisory Committee**, in its 20th year, works with the *Department of Criminal Justice, Criminology & Forensics* through our *Crime & Justice Research Center* to develop collaborative initiatives including research, internships, practicum courses, continuing education, and public events. Agencies on the committee and individual committee members help our students succeed in professional career advancement.



SUMMARY OF LAST YEAR'S MEETINGS



Our 2022 meeting was back in person! The 2022 *Innovation in Criminal Justice Education Award* was awarded to **Mac Pevey** and the *Distinguished Alumni Award* went to **Jonathan “Zack” Gallar**.

Our featured discussion in 2022 was “*How has the criminal justice system changed since 2020 – What has/has not changed?*” We discussed how we can best educate students for criminal justice roles across the span of the system to reflect the Jesuit tradition of *Cura Personalis* to “Educate Leaders for a Just and Humane World” and how to prepare students in the new and changing cultural landscape. In our mid-year meeting, SUCJ faculty members Dr. **Pete Collins** and **Brooke Gialopos**, along with research assistant **Bailey Tanaka** and advisory committee member **Frank Thomas** presented their findings from their study of Diversity in Jury Summons in Washington State with **Cynthia Delostrinos Johnson**, and **Judge Rosen**.

Departmental Update

ENROLLMENT/STUDENT INTEREST

We begin the 2023-2024 academic year with **361 students- 282 undergraduate students, 79 graduate students, and 10 Crime Analysis Certificate students.** In the undergraduate program, forensic psychology is the most popular specialization with 105 students – 63 BA/42 BS (37% of all CJ undergrads) followed by administration of justice with 59 students (21% of all CJ undergrads), forensic science with 58 students – 7 BA/51 BS (21% of CJ undergrads), and criminology with 49 students (17% of all CJ undergrads), and law with 11 students (4% of all CJ undergrads). The most popular graduate program specializations are Investigative Criminology with 32 students (41% of all grad students) and MACJ (no specialization) with 21 students (27% of all grad students), with the remainder of the students in Victimology with 11 students (14% of all grad students), the Research and Evaluation specialization with 7 students (9% of all grad students), and the MACJ/JD with 3 students (4% of all grad students).



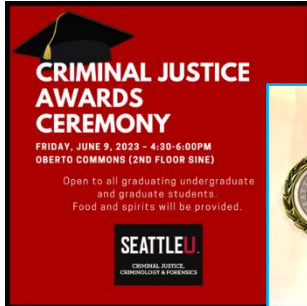

Our MACJ Program is continuing to be strong. For the 2023-2024 academic year, we have 35 incoming MACJ students both in the on-ground and new online program! The selected students attending our program are from the local area and out of state and country. Student Awards and Departmental Honors

The *Corr Scholarship* goes to the incoming graduate student who honors CJ Department co-founder and former Seattle Police Department Assistant Chief Eugene Corr's vision to increase women and minorities in law enforcement. The 2023 Corr Scholarship was awarded to MACJ/Investigative Criminology student **Ana Carpenter**.



The 2023 *Norm Maleng Academic Excellence and Citizenship Award* went to **Brandon Bledsoe** (MACJ).

Brandon will pursue a PhD in Criminal Justice at the University of Cincinnati. The award is named in honor of Norm Maleng, former King County Prosecutor. Norm was a CJ Department Advisory Committee member who was instrumental in inspiring the inclusion of the Victimology Graduate Specialization. Selection is based upon exceptional graduate work in the classroom and service to the community. Norm's family Judy and Marm Maleng presented Joslyn with the Maleng Award.



The *Blume Criminal Justice Scholars Program* was established in 2016 through a generous gift to our department from Ann and Bruce Blume to support advances in research and practice at the intersection of criminal justice and mental health. 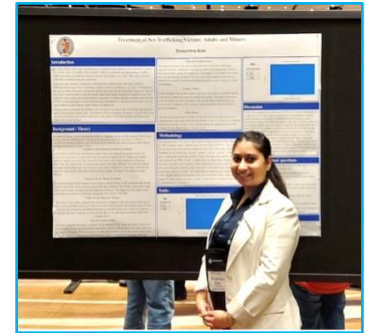

RESEARCH COLLABORATIONS

In 2022-2023, we engaged in many collaborative initiatives that involved students, faculty, CJ agency partners, and alumni. Here is a sample of the projects we worked on this year.



- **Seattle Police Department's Micro-Community Policing Plans** continues for its 9th year. **Jacqueline Helfgott** heads the SPD MCPP in collaboration with the **Seattle Police Department** with current Research Analysts BACJ Criminology student **Elaria Zakhary**

(North Precinct), BSCJ Forensic Science student **Quinn Priebe** (South/Southwest Precincts), BSCJ Forensic Psychology student **Ana Carpenter** (East/West Precinct), BSCJ Forensic Science student **Zachary Dar** (Citywide) and MACJ student **Eden Sedgwick**.



The MCPP has employed 40 students to date as SPD civilian Research Analysts, most of whom have been hired with SPD or other CJ agencies upon graduation. Over the spring/summer 2023, the MCPP

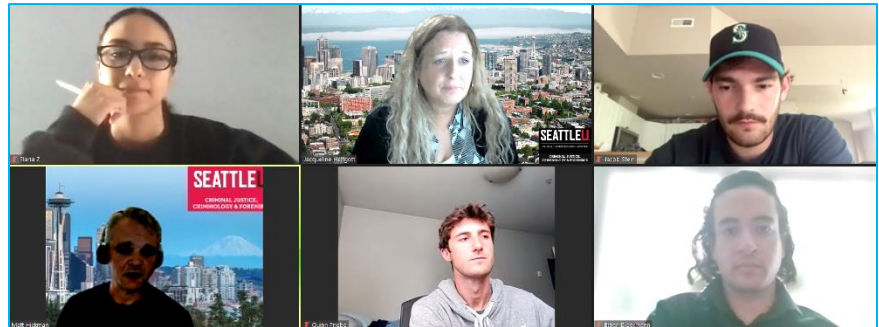
research team conducted 15 virtual community-police dialogues that brought together community members and police to engage in conversation. This fall the team is facilitating a special series of MCPP Community-Police Dialogues for the new SPD "Before the Badge" training program for new recruits. The dialogues focused on public safety concerns and how the community and police could work together to increase public safety and neighborhood quality of life. Reports on this research are available on SPD MCPP and CJRC websites.

- **Denver Police Department's Micro-Community Policing Plans** is launching October 2023. This will be the first official replication of the SPD MCPP in another city! This will be a collaboration with the Denver Police Department with Jacqueline Helfgott, Matt Hickman, and MACJ alums and former SPD MCPP



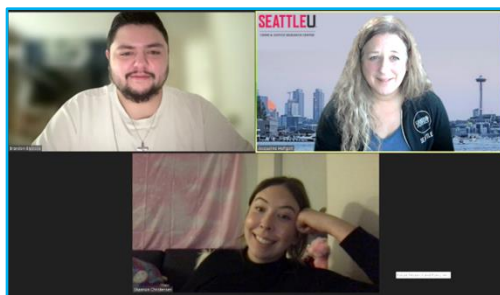
Research Analysts Brandon Bledsoe and Shannon Christensen working on the project.

- Evaluation of the Seattle Police Department’s “Before the Badge” Training Program.** **Jacqueline Helfgott** and **Matt Hickman** are leading a longitudinal evaluation of the **Seattle Police Department’s** new “Before the Badge” (BTB) training program with research assistants BSCJ Forensic Science student **Quinn Priebe**, BACJ Criminology student **Elaria Zakhary**, BACJ and Law student **Jacob Stein**, and MACJ student **Ethan Dieckman**. The evaluation will utilize the survey instrument developed in the prior longitudinal evaluation of the WSCJTC BLEA guardian law enforcement training and will involve interviewing and collecting survey data from SPD recruits and a comparison group of WSCJTC BLEA recruits over three years.



- Analysis of Jury Pool Representation in Washington State.** Peter Collins and Brooke Gialopsos continue to partner with the Administrative Office of the Courts on their statewide study of jury summons and diversity. MACJ student Bailey Tanaka is assisting as a research assistant on this study.
- Defunding the Police? Analyzing the Relationship between Police Funding and Crime Rates.** Professor **Carmen Rivera**, alongside **Danielle Miller**, **An Than**, and **Lily Garcia**, researched and analyzed the relationship between police budgets and crime rates. The researchers collected 17 different cities police budgets and crime rate reports throughout Washington state between 1990 and 2020.

- The Impact of Restorative Community-Police Dialogue Circles on Criminal Justice Student Ratings of Police Legitimacy.** MACJ alums and former SPD MCPP Research Analysts **Brandon Bledsoe** and **Shannon Christensen** and Professors **Jacqueline Helfgott** and **Brooke Gialopsos** are working on a paper and presentation for the 2023 American Society of Criminology conference in Philadelphia in November. This paper reports results from the collaboration with the Seattle Police Department on the Restorative Community-Police Dialogue Circles headed up by advisory committee Sergeant **Matthew Roberson** and Officer **Aaron Lucas** conducted in 2022 and 2023.

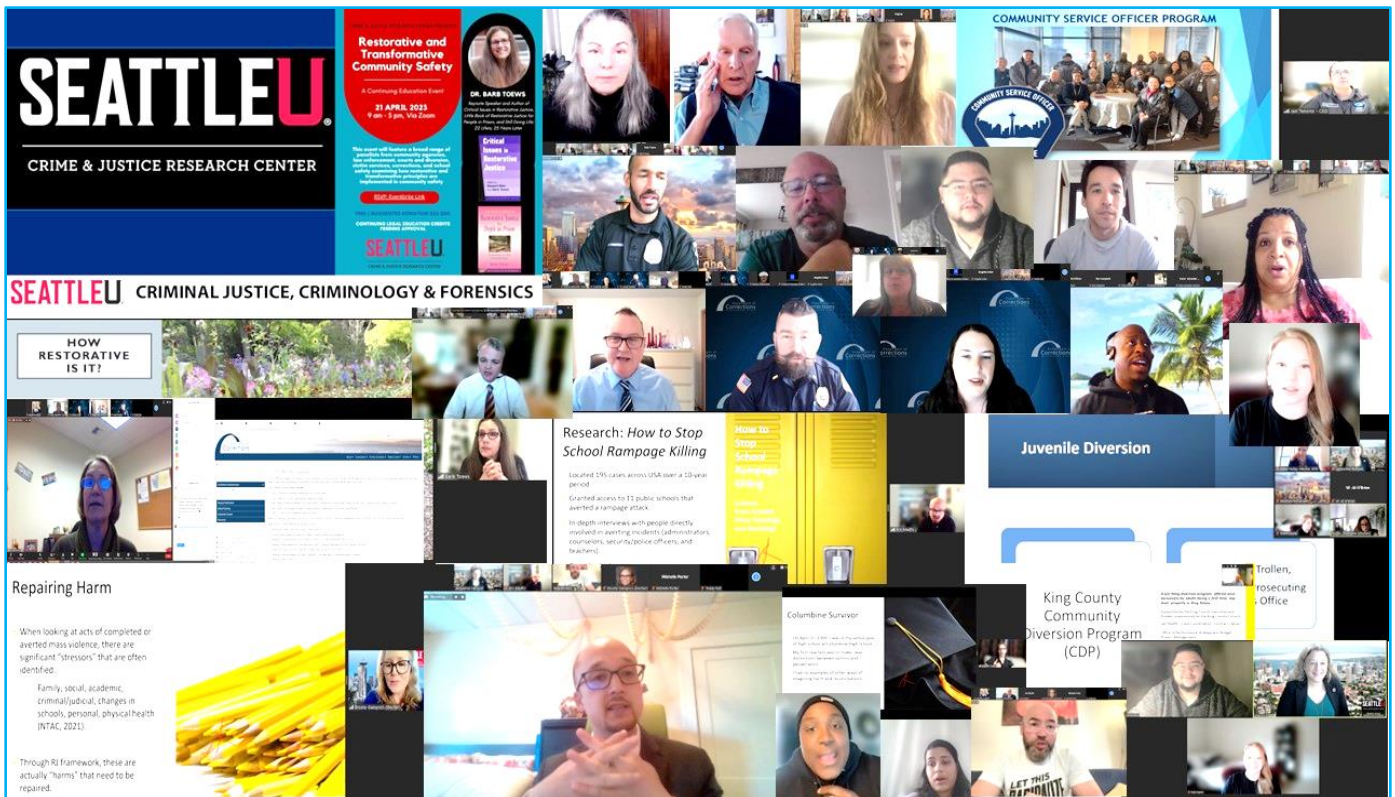


CONTINUING EDUCATION AND PROFESSIONAL TRAINING AND PROFESSIONAL SERVICE

National Research Conference 2023

The NIJ held its first national research conference in 12 years in May 2023. The theme of the conference was *Evidence to Action* as the NIJ brought together a wide variety of criminal justice scholars and practitioners in Arlington, VA to share knowledge about the latest research and how it can be applied practically in the criminal justice system. As a part of the NIJ's commitment and investment into the next generation of criminal justice professionals, they fully funded 25 graduate students across the United States to attend the conference. 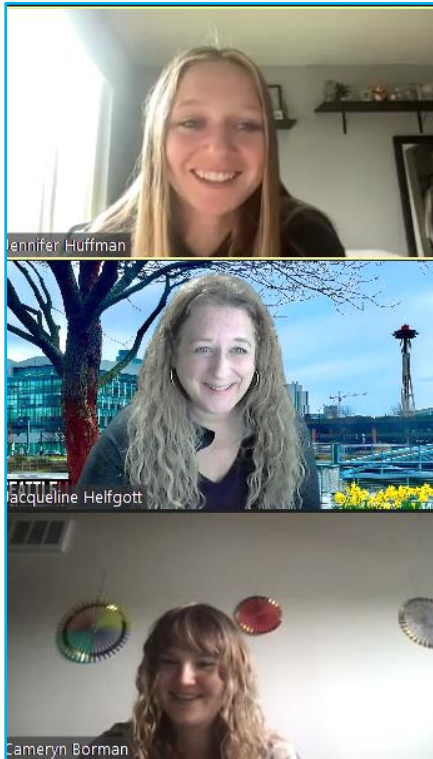
