#### Advisory Committee Overview

The Seattle University Criminal Justice Department Advisory Committee is in its 15<sup>th</sup> year. The advisory committee works with our department through our Crime & Justice Research Center to develop collaborative initiatives including research, internships, practicum courses, continuing education, and public events. Our department's high level of engagement with local, state, federal, and private criminal justice partners through our advisory committee has put our department on the map as one of the most well-connected and applied criminology and criminal justice academic departments in the world. The committee ensures that we keep our students informed about the ways in which their academic work links to real-world criminal justice practice and connected to professional networks that help them succeed in professional career advancement. Not a year goes by without innovative ideas put forward by committee members that enhance our department's curricular offerings and initiatives. The committee continues to grow and in the past year we have expanded to include private agencies inspired by students who have graduated and hired in the private sector. We now have 55 agencies represented with over 100 members on the committee.



#### SUMMARY OF LAST YEAR'S MEETING

In our 2017 meeting Seattle Police Chief Carmen Best was awarded the *Innovation in Criminal Justice Education Award* along with Assistant Chief Adrian Diaz and former Chief Kathleen OToole for their work with our department on the Seattle Police Department's Micro-Community Policing Plans which to date has employed 22 SU-CJ students as research analysts



who work in civilian positions with SPD. The initiative continues as an ongoing partnership and the students who have worked in the RA role have gone on to work at SPD and other police agencies upon graduation. Alumni (Jennifer Burbridge – SPD, Asen Deshev-WA DOC, Karolyn Kukoski-DSHS/SCC, and Ellary Collins-DSHS/Echo Glen presented the work they are doing in an "Alumni Showcase,"

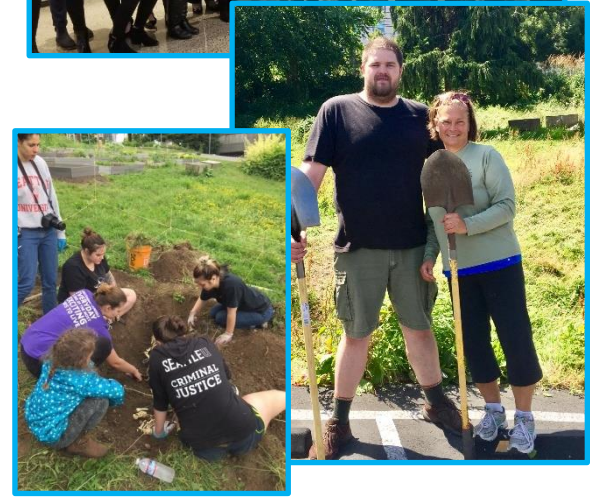

## ENROLLMENT/STUDENT INTEREST

For 2018-19 we begin the year with 315 students including 221 undergraduate students, 94 graduate students, and 12 Crime Analysis Certificate students. As of Fall 2018, we have a 5% increase in enrollment since 2017 and 20% since 2016. In the undergraduate program, forensic psychology is the most popular specialization area with 102 students – 86 BA and 16 BS (46% of all majors), followed by forensic science with 41 students – 15 BA and 26 BS (34% of all students), criminology with 49 students (22% of all majors), and administration of justice with 29 students (13% of

all majors). Graduate program enrollment remains strong with 32 incoming students. The most popular graduate program specializations are Investigative Criminology with 47 students (50% of all graduate students) and the MACJ (no specialization) with 22 students (23% of all graduate students), with the remainder of the students in the Research and Evaluation specialization with 7 students (7% of all graduate students), Victimology with 11 students (12% of all graduate students), and the MACJ/JD with 6 students (6% of all graduate students). The selected students graduate attending our program are from the local area and out of state and country. Our new students are graduates of University of Washington, Washington State University, St. Martins, Central Washington University, Pacific Lutheran University, University of Florida, Dixie State University, University of Virginia, Bastyr University, Columbia College, Greenville College, La Sierra University, and other universities around the country and are working at criminal justice agencies including Port of Seattle Police, DSHS, Pioneer Human Services, and Navos.

## STUDENT AWARDS

The undergraduate awards include the *Kelliher Award* for the highest GPA in the major and the *Corr Service & Ethics Award* named for CJ Department co-founder Eugene Corr, former Assistant Police Chief for the Seattle Police Department honors a graduating senior in the Criminal Justice Department undergraduate program who has made significant service and ethics contributions to the criminal justice system. The Kelliher awardees for 2017 were **Gillian Knapp (BACJ-Forensic Psychology)**, **Paige Treff (BACJ – Forensic Psychology)** and **Destinee Ripperger (BSCJ – Forensic Science)**. The Corr Service & Ethics Award went to **Nadine Guyo (BACJ –Forensic Psychology)**.

The 2018 Corr Scholarship was awarded to incoming MACJ student **Christy Saevivat**, who works as a case manager with Compass housing, has been a case manager with CCO, and seeks a career in law enforcement.



The 2018 *Norm Maleng Academic Excellence and Citizenship Award* went to **Tia Squires**. Tia is a MACJ/JD student who graduated with her MACJ Investigative Criminology in June 2018 and will complete her JD degree in December 2018. Tia also is part of the research team examining the reentry trajectories of women coming out of the Washington Corrections Center for Women as part of the evaluation of Seattle Women's Reentry. The Norm Maleng Academic Excellence & Citizenship Award is awarded to an outstanding graduating student in the Master of Arts in Criminal Justice program. The award is named in honor of Norm Maleng, former King County Prosecutor, who for 30 years was a vocal advocate for reform in criminal justice and introduced many programs in Seattle related to victim's rights and drugs. Norm was a CJ Department Advisory Committee member who was instrumental in inspiring the inclusion of the Victimology Graduate Specialization. Selection is based upon exceptional graduate work in the classroom and service to the community. Tia was presented the award at our end-of-year celebration for SUCJ graduates by Judy Maleng, Norm's wife and Mark Maleng, Norm's son.

**CRIME & JUSTICE RESEARCH CENTER INITIATIVES**

**RESEARCH COLLABORATIONS**

In 2017-18 we engaged in a range of collaborative initiatives that involved students, faculty, CJ agency partners, and alumni. Here is a sampling of the many projects we worked on this year:

- Faculty, students, alumni, and CJ partners presented papers at the *American Society of Criminology*, *Western Society of Criminology*, and the *Academy of Criminal Justice Sciences* 2017/2018 Annual conferences. CJRC funds help to send students to present at these conferences.



- SU-CJ Faculty **William Parkin** and **Jacqueline Helfgott** presented preliminary findings in New York City in March and July, 2018 at the site meetings for the Research Network on Misdemeanor Justice (RNMJ). **Lauren Morgan (MACJ '18)** and **Simran Kaur (BACJ Candidate)** worked as Research Assistants on the on the project and will be co-authors on the final report. Lauren Morgan will be presenting at the 2019 ASC Conference on the role of the RA on the project with RAs from the other 7 sites nationwide. The final report – *Misdemeanor Arrests, Referrals, and Charges in Seattle Final Report* will be released at our public event on October 25 11:30-1:30. RNMJ Preeti Chauhan (Director) and Meredith Patten (Executive Director) from John Jay College of Criminal Justice in NYC will be visiting Seattle for the release.

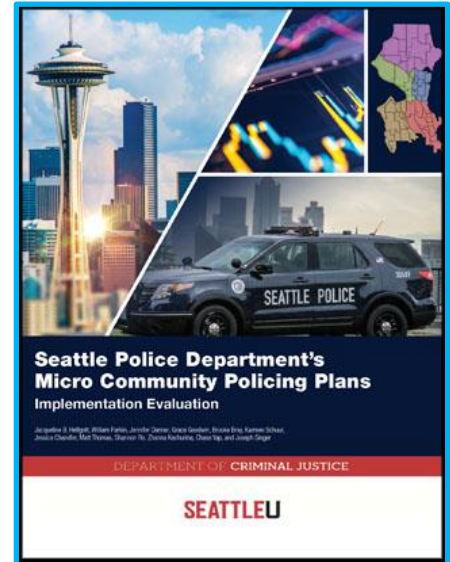


- *The Seattle Police Department's Micro-Community Policing Plans Final Report* was published in conjunction with the Community Oriented Policing Services (COPS) Office. The report is available on the [SPD MCPP](#) and [SU Crime & Justice Research Center](#) Websites.

The SPD MCPP and associated Seattle Public Safety Survey is in its 4<sup>th</sup> year headed by

SU-CJ's **Jacqueline Helfgott** and **William Parkin** in collaboration with advisory committee members SPD Chief **Carmen Best**, Assistant Chief **Adrian Diaz**, and SPD Personnel at all SPD Precincts. This initiative has employed 22 students to date as paid RAs working as civilian employees for SPD engaged in community outreach and data analysis most of whom have immediately secured positions with SPD and other CJ agencies upon graduation.

- Research continues on the *Longitudinal Study of the Guardian-Oriented Police Training at the Washington State Criminal Justice Training Commission* headed by SU-CJ faculty **Jacqueline Helfgott** and **Matt Hickman** in





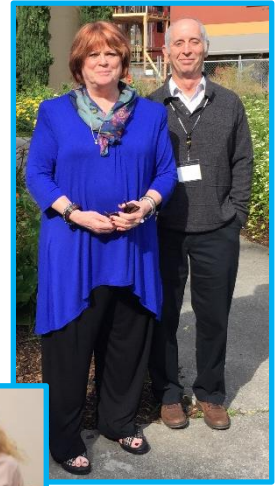
collaboration with advisory committee members WSCJTC Executive Director **Sue Rahr** and Deputy Director **Chris Fowler** assisted **Emily Malterud (MACJ '18)** who worked as a Research Analyst at WSCJTC during the 2017-18 academic year. 2015 and 2017 Reports on this research are available on the CJRC web page and the 2019 report will be available after June 30, 2019. SU-CJ Faculty Jacqueline Helfgott will also be assisting in the outcome assessment for the *WSCJTC 21<sup>st</sup> Century Police Leadership Training (21CPL)*.

- Evaluation of the *SPD IF Project's Seattle Women's Reentry* initiative continues for an extended final year. This project is funded by the Bureau of Justice Assistance and involves following women released from the Washington Corrections Center for Women in 2017 and 2018 for three years post-release. The research is headed by SU-CJ faculty **Jacqueline Helfgott** and **Elaine Gunnison** in collaboration with advisory committee member Seattle Police Department's **Kim Bogucki** assisted by research assistants **Tia Squires (MACJ/JD '18)**, **Kidst Messelu (BACJ '13/MACJ '18)**, and **Nadine Guyo (BACJ '18)**. In addition, **Emily Stefhon (BACJ Candidate/2018 Undergrad Blume CJ Scholar)** is now working as administrative assistant with Kim Bogucki and the IF Project.

**CONTINUING EDUCATION AND PROFESSIONAL TRAINING**



- On June 1, 2018 we held a continuing education event on *Social Media and Crime* featuring Dr. Mary Ellen O'Toole, former FBI Agent and author of *The School Shooter: A Threat Assessment Perspective*, Director of George Mason University Forensic Science Program and Editor of *Violence & Gender* and Dr. Ray Surette from University of Central Florida and author of *Media, Crime, & Justice* and multiple works on copycat crime.
- On June 2, 2018 we held a *Copycat Crime Research-a-thon* for students. This was a live data collection activity in which students collected open-source data on copycat crime and listened to featured speakers Dr. O'Toole and Dr. Surette and guest speakers including advisory committee members SPD's **Brian Stampfl**, KCPAO's **Karissa Taylor** as well as Steve Militech from the Seattle Times, Renee Hopkins from the Alliance for Gun Responsibility, and faculty from the SU Film Studies and Department of Communications.



**PUBLIC AND PROFESSIONAL SERVICE**

- Our faculty regular contribute to media interviews on a range of criminal justice topics. In 2017-18 faculty commented on stories involving death penalty, police use of force, media and crime, police training, guns and violence, public safety, offender reentry. Media interviews include SU-CJ faculty **Matthew Hickman's** comments in "Does News about Police Being Killed in the Line of Duty Impact Police Violence?" in *The Stranger* and "Fired, But Fit for Duty: Impunity for bad policing in Oregon" in *The Oregonian* and "Convicted, but Still Policing" in the *StarTribune* and Jacqueline Helfgott's appearance on *Kiro 7 News* Town Hall ("An urgent conversation about guns") *King 5 New Day NW* on a segment ("Is the Mean World Syndrome affecting how you view your community?") and comments in *The Seattle Times* ("Mean World Syndrome': In some Seattle neighborhoods, fear of crime exceeds reality), *Real Change* ("Homelessness among top crime concerns in Seattle U Survey") and *My Statesman* ("Is Austin training police to be too aggressive")
- SU-CJ faculty Op-Eds this year include **Jacqueline Helfgott's** "Background checks give false sense of security at airports" in *Crosscut*.
- SU-CJ's faculty **Pete Collins** testified at the *Washington State Legislature* during the legislative session on his ongoing work on the economic cost of the death penalty including work SU-CJ **Matt Hickman** and with advisory committee member **Bob Boruchowitz**.
- SU-CJ's faculty **William Parkin** conducted a survey and data analysis for the Seattle Chinatown International District Preservation & Development Authority (SCIDpda).
- **Jacqueline Helfgott** and **William Parkin** hosted two groups from the Boston College Global Leadership Institute with the help of students and alumni who have worked as RAs for the SPD MCPPP Initiative and the WSCJTC Evaluation. We will have groups coming to campus again in 2018-19 through a partnership with BC's Global Leadership Institute-Mexico Program.

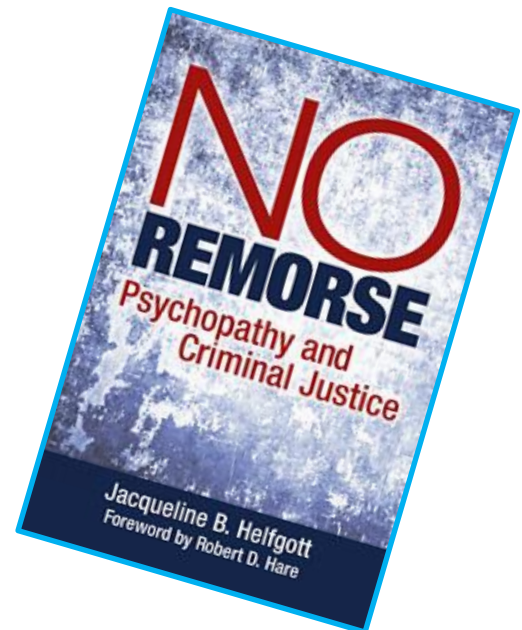
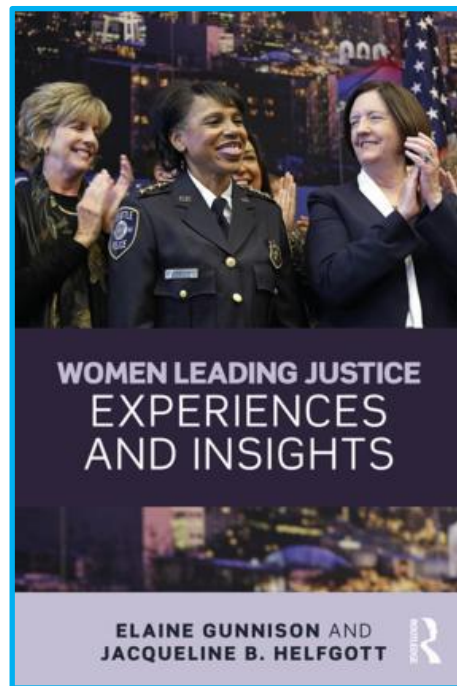
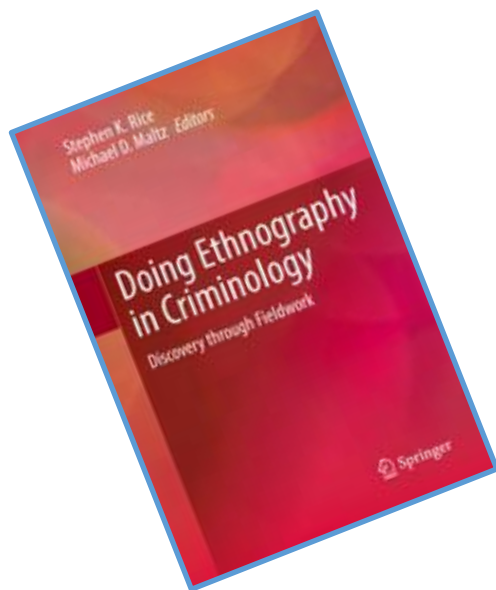
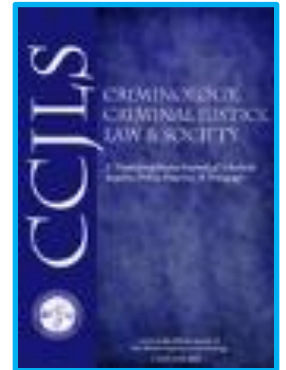




**FACULTY/STAFF HIGHLIGHTS AND PUBLICATIONS**

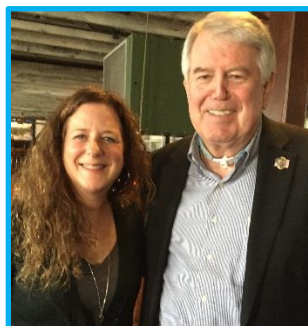

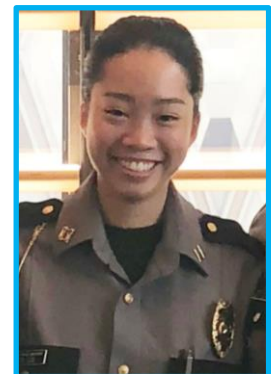

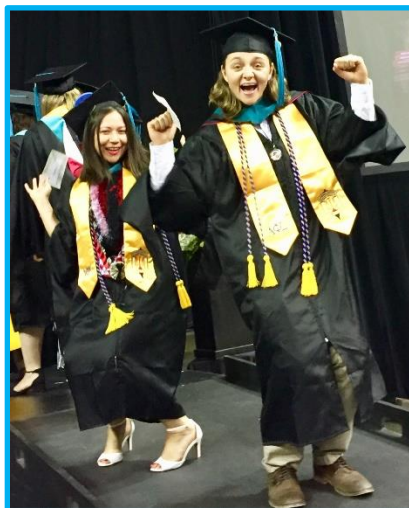
