Congratulations to our SU faculty and staff who submitted 87 proposals and received 65 new awards totaling \$6,477,271 in new funding over the 2021-22 fiscal year (FY22)! This reflects over a doubling of awards (110% increase) received over the previous year and a 28% increase in proposals submitted. Keep an eye out for our annual report coming out toward the end of summer for more details.

As we close out FY22, I want to express my sincere gratitude to OSP's Sponsored Research Officers **Kara Luckey** and **Sarah Bricknell** who have provided unfaltering support during times of unprecedented growth in both the number and complexity of proposals submitted and grants awarded. Identifying Funding Opportunities

GrantForward Database: OSP encourages faculty to explore <u>GrantForward</u>, a funding opportunity database and recommendation service available to all members of the SU community. GrantForward has many helpful features, including a dynamic search engine with customizable filters and mechanisms for developing regular funding alerts that are sent directly to you on a regular basis of your choosing. An overview about GrantForward with instructions for getting started is available <u>here</u>, with additional step-by-step guides available <u>here</u>. Funding Opportunity Screening Worksheet: Once you've identified a potential funding opportunity, use **this screening worksheet** developed specifically for SU grant seekers to assist in determining its fit with your research agenda.

Research Development and Proposal Writing Resources

Developing a Research Roadmap: OSP has a variety of resources available to support you in developing a 'roadmap' and funding plan that maps research interests, capacities, and potential funding opportunities to identify pathways for achieving near-and long-term goals. Materials, including a **resource sheet**, and **Research Roadmap** and **5-Year Funding Plan** templates, are available **here**.

Essentials of Proposal Development: Grant-seekers interested in learning more about positioning oneself for successful proposal writing – including critically reviewing funding announcements, developing project aims that respond to sponsor objectives, strategically conceptualizing projects, crafting compelling proposal narratives, and tips for using language effectively – are encouraged to make use of the many resources available here, including Resource Sheet, Pro-tips from grants-active SU faculty, and brief 'Grant-writing Cheat Sheet.'

Developing a Grant Proposal Budget: A number of resources available <u>here</u> provide support in developing this often overlooked component of a proposal, including a <u>sample budget</u>, <u>sample budget</u> <u>justification</u>, and <u>Resource Sheet</u>.

Federal Agency Proposal Resources: Are you planning to submit a proposal to the National Science Foundation (NSF) or National Institutes of Health (NIH), or want to become more familiar with their

proposal requirements? Visit our <u>NSF Proposal Guide</u> and <u>NIH Proposal Guide</u> to find guidance and templates on required sections of these proposals. Other excellent resources include recording and materials from our faculty learning session "<u>The Room Where it Happened: Insights from Grant Review Panels</u>," in which SU faculty shared their lessons learned from serving as reviewers for federal and other agencies. A recording and materials are also available from our spring 2021 info session with a **National Endowment for the Humanities (NEH) Program Officer**.

Two faculty awarded prestigious fellowships for AY2022-23

Dr. Carlyn Ferrari, Assistant Professor of English, has been named by The Institute for Citizens & Scholars as one of their Career Enhancement Fellows for the 2022-23 academic year. This highly competitive, national fellowship, funded by the Mellon Foundation and administered by Citizens & Scholars, seeks to increase the presence of minority junior faculty members and other faculty members committed to eradicating racial disparities in core fields in the arts and humanities. "This fellowship will allow me to expand my sabbatical time to focus on my current book projects on poet and civil rights activist Anne Spencer, whose poetry and prose invites us to think about the natural world from a Black woman's perspective," says Dr. Ferrari.

Dr. Kumhee Ro was selected as a 2022 Robert Wood Johnson Foundation Health Policy Fellow, a highly-competitive program in which exceptional mid-career health professionals participate in the policy process at the federal level and use that leadership experience to improve health equity, health care, and health policy. The fellowship begins with an intensive 3-month orientation conducted by the National Academy of Medicine. Dr. Ro will devote the entirety of the 2022-23 academic year to the program. During that time, she will reside in Washington, DC and work within a Congressional office or in the Executive Branch to develop expertise in the policy process and participate in training in health equity topics, media training, coaching, and leadership development. After the Washington DC assignment, the fellows will continue to receive support to sustain their development as health policy leaders. Fellows are expected to use the experiences, leadership skills, and relationships gained through the experience to advance health care policy and equity and the national, state, and/or local levels.

Both Dr. Ferrari and Dr. Ro's fellowships will be administered by Seattle University. Other fellowship programs make awards directly to individual faculty members. OSP is aware of several recent fellowships awarded in this manner, including **Dr. Serena Chopra**, Assistant Professor of English and Creative Writing (MacDowell Fellowship), **Dr. Serena Cosgrove**, Associate Professor of International Studies (Fulbright Scholar Award) and **Dr. Michael Jaycox**, Associate Professor of Theology and Religious Studies (Lendrum Priory Library Fellowship at Durham University, UK). While OSP does not manage the fellowship awards in these cases, we are certainly available to support faculty in developing competitive proposals and exploring opportunities that leverage the work conducted during the fellowship period!

SU Policy Updates

Reminder: CITI Training Required for NSF and NIH-Funded Researchers

A reminder to SU investigators to please ensure that all personnel working on your research team – students, staff and faculty – are up-to-date on their Responsible Conduct of Research (RCR) Training. RCR training is required for all NSF and NIH personnel and strongly encouraged for all other researchers to uphold SU's commitment to responsible and ethical research. This training should be completed at least every four years. More information and to access the CITI Training Modules is available here.

Updated: NSF/NIH Workplace Health and Safety Notification Protocol

To better align with the NIH's recent update to their Requirements for NIH Notification of Removal or Disciplinary Action Involving Program Directors/Principal Investigators or other Senior/Key Personnel, the SU NSF/NIH Sexual Harassment, Other Forms of Harassment, and Sexual Assault Notification Protocol has been updated and renamed. This policy is relevant to Principal Investigators and other Senior/Key personnel funded by the NSF or NIH related to concerns about sexual harassment, bullying, retaliation, other forms of harassment, sexual assault, hostile working conditions, or any other conditions that raise a concern about workplace health and safety which may affect their employment status. Clarification on Limited Signature Authority for Sponsored Projects

Despite limited signature authority delegated to college deans, all sponsored project-related contracts and agreements must continue to be processed through the OSP consistent with the **Contract Review and Approval Policy**. OSP will coordinate the required signatures for such contracts.

In particular, the policy articulates that all contracts and agreements related to sponsored projects – including contracts issued by SU through funding from an external sponsor or otherwise involving sponsored projects – must be processed by the OSP and may require additional review by University Counsel. Furthermore, the policy clarifies that only authorized officials may execute contracts on behalf of SU.

All externally-funded investigators leading projects that involve contracts between SU and an outside entity are advised to consult with your **Sponsored Research Officer** who will help in identifying the required steps.

Sponsor Policy Updates and Resources

National Science Foundation (NSF)

Research.gov required as of January 1, 2023: NSF has announced that Research.gov will be required for the preparation and submission of *all* proposals as of January 1, 2023. Proposals to most programs are currently available in Research.gov (see full list here). NSF's old grant submission and management portal, FastLane, will be removed in January 2023. NSF has posted additional training resources for submitting to Research.gov, including short video tutorials about setting up proposals, uploading documents, and checking for compliance with NSF formatting requirements. Of course, OSP staff are also available to support any prospective NSF investigators who are new to Research.gov.

SciENcv to be required for all NSF Biosketches and Current & Pending Support, effective January 1, 2023: NSF has released the <u>draft updated Proposals & Awards Policies & Procedures Guide (PAPPG)</u>, anticipated to be effective for proposals due on or after January 1, 2023. Proposed significant changes include required use of <u>SciENcv</u> for preparation of Biographical Sketches and Current & Pending Support as well as changes to requirements around certifying and updating Current & Pending Support.

As always, **your Sponsored Research Officer** is available to help faculty understand all requirements of the NSF!

National Institutes of Health (NIH)

NIH expands notification requirements involving disciplinary action: The NIH recently released this notice regarding updates to requirements around notifying NIH of removal or other disciplinary action involving NIH-funded Principal Investigators, Program Directors, and/or other Key Personnel. This updated policy expands the circumstances in which institutions are required to notify NIH of disciplinary actions taken in regards to NIH-funded investigators. As described above, the SU NSF/NIH Workplace Health and Safety Policy has been revised in adherence to this update.
